Discussion:

Prof. Dr. S.K. Patil communicated members that last year we have started B.Sc. in Fashion and Apparel Design as per demand of students of Diploma in Fashion Designing. By taking into consideration the requirement of students of Diploma in Interior Designing we are proposing to commence new three-year degree programme B.Sc. in Interior Designing from the academic year 2024-2025.

Hon. Dr. Anil Patil communicated that now B.M.S. degree has been detached from affiliation of University of Mumbai and is being instructed to take affiliation from AICTE. He suggested to check whether this B.Sc. in Interior Designing is coming under AICTE.

Dr. S.T. Gadade, Secretary communicated that if the degree is coming under the AICTE then the nomenclature of the degree shall be changed to keep it affiliated to the University.

Resolution:

After detailed discussion and considering suggestions given by Hon. Dr. Anil Patil and Dr. S.T. Gadade, it is resolved that new three-year degree programme B.Sc. in Interior Designing shall be commenced under affiliation with University of Mumbai and not with AICTE. To keep this degree affiliated to University of Mumbai appropriate changes required in syllabus or nomenclature of the degree shall be incorporated and then only the programme shall be commenced from the academic year 2024-2025.




