e-Governance Policy

e-Governance refers to the **use of Information and Communication Technology** (**ICT**) in order to provide services and communication and exchange of information between different governance heads in a speedy, efficient manner to expedite work. In Changu Kana Thakur Arts, Commerce and Science College, e-governance includes all the online services provided by the institute. Appropriate MIS software shall be purchased by the college in order to employ e-governance in different aspects of governance as under:

1. Planning and development: MIS software shall be used for:

- a. Planning of admission
- b. Planning for collection of student fees
- c. Planning of annual budget for income and expenditure
- d. Annual planning for Library as regards acquisition of resources, their maintenance and proper profitable usage.
- e. Planning for monitoring, recording and feedback on attendance of students
- f. Planning for evaluation of students through systematic and timely examinations through the academic year.

2. Administration: MIS software shall be used for:

- a. Maintenance of all data of students, teaching as well as non-teaching staff and making it available in specific formats whenever required.
- b. Student registration and generation of merit lists.

- c. Collection of fees and generation of fee receipts.
- d. Generation and maintenance of attendance reports
- e. Generation of various certificates such as Transfer Certificates, Transcript, NOC, bonafide etc.
- f. Generation of all the reports pertaining to students.

3. Finance and Accounts: MIS software shall be used for:

- a. Maintenance of fee record of students.
- b. Maintenance and monitoring of records of fee instalments.
- c. Generation of DCR reports.
- d. Generation of receipts for expenses and vouchers.
- e. Generation of reports as regards income, expenses and balance sheets.

4. Student admission and support: MIS software shall be used for:

- a. Online admission process
- b. Availability of prospectus, online registration of students, generation of updated merit lists for admission.
- c. Android app support for online payment of fees, mailing and bulk SMS.

5. Examinations: MIS software shall be used for:

- a. Registration through filling of exam forms.
- b. Preparation of seating arrangements charts.
- c. Assignment of Examination seat numbers.
- d. Generation of Hall tickets.
- e. Entry of marks, generation and declaration of results.
- f. Production of mark sheets, grade cards and different types of reports in required formats.
