## **Policy on Divyangjan-friendly Environment**

The Changu Kana Thakur Arts, Commerce and Science College, New Panvel (Autonomous) recognizes that persons with disabilities are valuable human being for the society and seeks to create an environment that provides equal opportunities, protection of their rights and full participation in all activities of the institution. The differently-abled persons need special arrangements in the campus for their mobility and independent functioning. The Persons with Disabilities Act 1995 indicates that differently-abled persons should have access to education at all levels. Keeping in view the need to provide special infrastructure to differently-abled persons, the institution has created special facilities and made other necessary changes to suit the special needs of differently-abled persons. We strongly prohibit the all kinds of discriminations against differently abled individuals in any aspect. For maintaining it, we provide all kinds of benefits to the differently abled spirits in all grounds of programs, administrations and activities.

The focus of the policy shall be on the following:

- Barrier-free environment
- Social Security
- Preference in admissions for Persons with Disabilities
- Sports, Recreation and Cultural life

### **Objectives:**

1. To create all-inclusive culture and atmosphere in the premises to avoid any kind of discrimination, exploitation and exclusion of differently abled individuals over the periphery of scope.
2. To provide comprehensive and easily accessible opportunities and services in all regards of the development to the differently abled individuals.
3. To ensure the benefits of the all kinds of Government Schemes and scholarships entitled to the differently abled individuals.
4. To expose the differently abled individuals to the barrier free environment.
5. To direct and confirm the physical, educational and economical rehabilitation of the differently abled individuals.




6. To build differently abled characters through implementation of 3Ds Viz. Determination, dedication and discipline.
7. To get approved and sanctioned necessary budget for achieving the said objectives and directives.
8. To understand and regulate for the solutions pertaining to the grievances to any kind of issues of the differently abled individuals.

**Facilities available for Students and Employees:**

1. Separate and accessible wash rooms are provided for the differently abled individuals.
2. Wheel chair is provided with human assistance to the physically disabled for their free movement.
3. Ramps are provided at designated places wherever necessary.
4. Lift facility for the differently abled individuals.
5. Facilities as per different government sanctioned schemes from time to time with up gradation and integration.
6. For visually impaired students and staffs, we have special software's like KIBO for user friendly assistance.
7. Disability sensitization sessions for the differently abled staffs and students.
8. Library facility like reservation of book bank, human assistance for ensuring trouble free access to literature and reserved reading spaces for individuals.
9. Provision for enquiry and information, human assistance, reader, soft copies of learning materials, screen reading software's accessible website etc.
10. Allocation of the classroom and examination center with easy access.
